- a) The pet will be kept within the lot while it is present on the scheme land;
- b) The pet will not be permitted to roam the common property or into other lots in the scheme
- c) If the pet traverse's common property it will be only for the purpose of being brought onto or taken off the scheme land, and at which time the pet will be carried or otherwise adequately restrained;
- d) The pet will not be permitted to make noise, or otherwise cause a nuisance, such that it interferes unreasonably with any persons use or quiet enjoyment of another lot or common property;
- e) Reasonable steps must be taken to minimize the transmission of airborne allergens from the pet to other lots or common property, for example, by vacuuming the lot and/or grooming the pet;
- f) Reasonable steps must be taken to keep the pet in good health and free from fleas and parasites;
- g) The pet will not be permitted to defecate on the common property and any animal litter or waste associated with the pet will be effectively and promptly cleaned from the scheme land and be properly disposed of by me/us, the pet owner/s;
- h) All applicable local government regulations regarding pets will be complied with;
- i) No additional, replacement or substitute animals will be permitted in the lot without prior written approval of the Body Corporate.

I agree to be bound by the directive of the Body Corporate and any reasonable conditions imposed on any such approval if approval is granted in respect of this request.
